- o Dan provides update on financials for organization for July 2025
 - a. He and Alison are meeting with bookkeepers
 - Seeking one that specializes in BID funding
 - In the middle of tax season and will talk further in coming days
 - b. Draft Budget
 - Created a draft budget from last year's actuals
 - 51% will be used for marketing with BID funding
 - Shared line-by-line expenditures
 - Business Member dues can be used for non-BID focused spending
 - O This is a specific review and not a full financial audit
 - c. Office Space
 - Interest in SBV having an office again
 - SBV has not had one since COVID
 - Could potentially combine office & storage
 - Can house Board of Directors meetings
 - Under Board advisement
 - o Making sure the estimate reflects the whole state of CA
 - o We have relayed a reasonable & conservative number throughout process
 - ii. Payment portal is being developed by HdL for wineries

 - Working through issues with both HdL & SBV
 - We are making sure our data is aligned
 - Actual numbers on money collected is forthcoming
 - b. Grant Writing
 - We are working with a local grant writer to apply for CDFA Specialty Crop Block Grant
 - There is a second CDFA grant that we will consider applying for as well
 - c. Brown Act Compliance Process
 - All SBV meetings are now open to public since BID was formed by Santa Barbara County Board of Supervisors

 - d. Annual Meeting Outline
 - Pierre will do introductions, followed by board members speaking about committees
 - Alison Walk through organization and upcoming strategy and budget
 - SBVF will have a speaker to give update on their organization

 - a. Transition & Strategy Committee (Jason, Pierre, Alison)

 - b. Marketing Firm Selection Ad Hoc Committee (Keith, Kevin, Chase, Brooke)

 - Will compare costs of all firms
 - Goal: Double DTC sales in five years
 - Joining actual Marketing Committee will be evaluated
